### Duration of the Contract

The duration of the Comprehensive, Third Party Fire and Theft or Third Party Only motor insurance cover contract is detailed on your Statement of Fact or Motor Proposal form included within your Welcome Pack.

### Cancellation Rights-Motor Insurance Policy

You can cancel your policy within 14 days from the receipt of your welcome/renewal letter or email. Your insurance provider will make a deduction for the time you have been on cover and we may also charge an administration fee.

Should you cancel outside the 14 days, your Insurance Provider will apply a charge for the time you have been covered under the policy. Charges can vary between Insurance Providers and are detailed in your policy documents. Gladiator will also charge a cancellation fee of £50. If a claim is made or has arisen during the period of insurance, the full premium is payable and no refund will be given.

The administration charges are payable to Able Insurance Services for the cost of arranging and handling your policy. Details of these charges are given in your Terms of Business, available on-line and included in your documents issued at inception and renewal.

### Cancellation Rights-Ancillary Products

You can cancel this product and receive a full refund, if you inform us within 14 days of the confirmation letter or email, subject to no claim being made. Should you cancel outside the 14 days, no refund will be given. If a claim is made or had arisen during the period of insurance, the full premium is payable and no refund will be given.

### Significant features and benefits

Unless you contact us we will automatically apply for your renewal premium from the payment details we have on file, prior to your renewal date. This is to make sure there is no interruption in your insurance cover.

### 2. Whose products do we offer?

- We offer products from a range of insurers.

can only offer a Breakdown Cover product provided by Call Assist Ltd and underwritten by Ageas Insurance Limited.

We can only offer Van Hire Cover provided by Auxillis Services Limited and underwritten by Zenith Insurance Plc. We can only offer Personal Accident Cover provided by Zenith Insurance Plc.

We can only offer Excess Protection Insurance provided by Auxillis Limited and underwritten by AmTrust Europe Limited. We can only offer Keycare Cover provided by Keycare Insurance Services Ltd and underwritten by Ageas Insurance Limited.

We hold as agent any insurance premiums collected on behalf of the insurers described above. We do not hold client money.

### 8. Are we covered by the Financial Services Compensation Scheme (FSCS)?

We are covered by the FSCS. You may be entitled to compensation from the scheme if we cannot meet our obligations. This depends on the type of business and circumstances of the claim. Insurance advising and arranging is covered for 90% of the claim, without any upper limit. For compulsory classes of insurance, insurance advising and arranging is covered for 100% of the claim, without any upper limit.
